Also this year stinkbugs (brown marmorated stink bug) start their journeys from these risk countries to Australia, threatening to destroy the local agriculture – but not with us! We hereby inform you, how your shipment will arrive at your customer – „bugfree“ – and what else you need to know:

When?

Shipped on board date on Bill of Lading from 01.09.23 until 30.04.24.

What?

All shipments containing Target High Risk Goods **must** be treated against BMSB.

The treatment may be done in the export country or after arrival in Australia.

Ro/Ro & breakbulk shipments, flat racks and open top containers **must** be treated at the port of loading. Our LCL consols are generally all being fumigated – please make sure that your goods are ready for fumigation, no matter what kind of goods you ship!

So called NUFT goods can be excepted from treatment. Check here if and where your shipment must be treated.

How?

Generally the complete container is being fumigated with Sulfuryldifluorid for at least 12 hours.

The outside temperature must be minimum +10°C during the whole treatment time.

Heat treatment around +60°C is also possible.

What to do?

- Clarify with your consignee timely before booking:
Who will pay for the treatment and where should it be done (FCL).
- Plan enough time for the treatment & order it in time.
- Make sure your cargo is ready for treatment before pick up of the goods.
The transport packaging must be permeable for the gas – cargo that is wrapped in foil cannot be fumigated unless the foil is sliced on all sides. Make sure that inside the container the gas has enough space to circulate.
